

# **Review of Paragraph Structure**

A **paragraph** is a group of sentences about a topic. A typical paragraph begins with a **topic sentence**, which introduces the topic. The sentences that follow support the idea in the topic sentence with explanations, reasons, and other details. The **concluding sentence** brings the paragraph to an end.

# Formatting a Paragraph

- Leave one-inch margins on the left and right side of the page.
- Indent the first sentence. The rest of the sentences follow each other, so that the paragraph looks like a square with a little space taken out of the corner.
- Double-space your paragraph.

# The Topic Sentence

An effective paragraph contains a good **topic sentence**. A successful topic sentence has the following features.

• It introduces the topic, or what the paragraph will be about. It also contains an idea or opinion about the topic. This idea is called a **controlling idea**.

Certain types of **insects** can benefit a garden.

• The topic sentence must not be a simple fact or detail. Instead, it must contain a specific idea. The idea or opinion must not be too general, or the topic sentence will be unclear.

There are approximately 4,000 chemicals in cigarette smoke. *(fact, not topic sentence)* 

Smoking is bad. (idea, too general for a topic sentence)

Smoking advertisements have a harmful influence on children. (specific idea)

• The topic sentence usually appears as the first or second sentence of a paragraph. Here it is the second sentence.

Have you ever noticed that closets are getting bigger and rooms are getting smaller? <u>Changes in popular culture can be seen in changes to the typical family home.</u>

• The topic sentence implies the purpose of the paragraph: to explain, narrate, compare, describe, explain causes or effects, demonstrate, argue, or provide the steps in a process.

My sister's personality is completely different from mine. (shows comparison) Smoking results in thousands of smoking-related deaths each year. (tells cause and effect)

# Unity within a Paragraph

Effective writing must have **unity**. A paragraph has unity when all the sentences support one single idea.

The paragraph must have one controlling idea in the topic sentence. Otherwise, the paragraph loses focus.

The supporting sentences must support, demonstrate, prove, or develop the main idea in the topic sentence. If they do not, they will be irrelevant or off-topic and destroy the unity of the paragraph.

The concluding sentence should restate the idea in the topic sentence to reinforce the main idea for the reader.

# Coherence in a Paragraph

**Coherence** in a paragraph means that the ideas have a logical flow: the relationship between the sentences is clear, and one idea connects to the next. One way to achieve coherence in a paragraph is to use a pattern of organization, such as **time order, spatial order**, or **order of importance**. To use time order, tell what happened first, next, and last. Spatial order is useful for describing items from top to bottom or from side to side. Paragraphs organized by order of importance might give the most important ideas first or leave them for last.

# **Important Rules for Acting on Stage**

For people who would like to act in the theater, there are several important rules to remember. One rule is to make sure you face your audience when you are on stage. If you turn away from the audience, they cannot see your facial expressions. The next rule is that you must make sure that you speak loudly enough. If your audience has difficulty hearing you, they will quickly lose interest. Another important point is to memorize your lines. Rehearse them often—on the train, in the mirror, or while you are walking to class—so that you remember them. Perhaps the most important rule of all is to remain calm on stage if you forget your lines. Don't panic and stop speaking because the audience will notice. Instead, make up something to say until you remember your next line. As long as you continue speaking and appear relaxed, the audience will probably not realize that you have made a mistake. In conclusion, following these rules will help ensure a successful stage performance.

# The Paragraph and the Short Essay

A **short essay** is longer than a paragraph, but like a paragraph it has three basic parts: an **introduction**, a **body**, and a **conclusion**.

# Introduction

• The introductory paragraph is the first paragraph of a short essay. It contains a topic sentence and **thesis statement**.

# **Body Paragraphs**

• A short essay has at least one or two body paragraphs. These develop the idea presented in the introduction.

# Conclusion

• The concluding paragraph is the final paragraph. It summarizes the idea(s) presented in the short essay.

# Short Essay Organization

An effective essay must have the following elements.

#### Introduction

- A hook is an opening sentence that attracts the reader's attention.
- The sentences after the hook give background information that helps the reader understand the topic.
- The last sentence in the introduction, the thesis statement, is very important because it gives the topic and the controlling idea of the entire essay.

#### **Body Paragraphs**

• An essay has at least one body paragraph in which the writer develops the thesis statement from the introduction. The body paragraph begins with a topic sentence, followed by supporting details.

#### Conclusion

• An essay ends with a conclusion that summarizes or restates the main idea in the thesis statement.

# The Sentence

A **sentence** contains at least one **subject** (a noun or a phrase) and a **verb**, and it expresses a complete idea. The verb expresses the action of the sentence, and the subject tells who or what completed the action. A **simple sentence** may contain more than one noun or verb.

Subject	Verb
The <b>dog</b>	runs.
The <b>dog</b>	runs and chases squirrels. (two verbs)
The <b>dog</b> and <b>cat</b>	run after squirrels. (two nouns in subject)

A complete sentence must contain at least one **main clause**. A main clause contains a subject and a verb, and it expresses a complete idea.

# The Compound Sentence

A **compound sentence** has two main clauses, separated by a **comma** and a **conjunction**, or by a **semicolon**.

# **Run-on Sentences**

A **run-on sentence** is not a correct sentence. In a run-on sentence, important punctuation is missing between the clauses. The sentence "runs on" too long and confuses the reader.

You can correct run-on sentences with a period, a comma and conjunction, or a semicolon.

- The dog runs fast it likes to chase animals in the park. (INCORRECT)
   The dog runs fast. It likes to chase animals in the park.
   The dog runs fast, and it likes to chase animals in the park.

Sometimes one particular experience can create a memory that stays with us for many years. The following reading describes Esmeralda Santiago's memories of the guavas she ate as a child.

# How to Eat a Guava

There are guavas at the **Shop & Save**. I pick one the size of a tennis ball and finger the prickly stem end. It feels familiarly bumpy and firm. The guava is not quite ripe; the skin is still a dark green. I smell it and imagine a pale pink center, the seeds tightly embedded in the flesh.

A ripe guava is yellow although some varieties have a pink tinge. The skin is thick, firm, and sweet. Its heart is bright pink and almost solid with seeds. The most delicious part of the guava surrounds the tiny seeds. If you don't know how to eat a guava, the seeds end up in the **crevices** between your teeth.

When you bite into a ripe guava, your teeth must grip the bumpy surface and sink into the thick edible skin without hitting the center. It takes experience to do this, as it's quite tricky to determine how far beyond the skin the seeds begin.

Some years, when the rains have been **plentiful** and the nights cool, you can bite into a guava and not find many seeds. The guava bushes grow close to the ground, their branches **laden with** green then yellow fruit that seem to ripen overnight. These guavas are large and juicy, almost seedless, their roundness enticing you to have one more, just one more, because next year the rains may not come.

A green guava is sour and hard. You bite into it at its widest point, because it's easier to grasp with your teeth. You hear the skin, meat, and seeds crunching inside your head, while the inside of your mouth explodes in little spurts of sour.

You **grimace**, your eyes water, and your cheeks disappear as your lips purse into a tight O. But you have another and then another, enjoying the crunchy sounds, the acid taste, the gritty texture of the unripe center. At night, your mother makes you drink **castor oil**, which she says tastes better than a green guava. That's when you know for sure that you're a child and she has stopped being one.

I had my last guava the day we left Puerto Rico. It was large and juicy, almost red in the center, and so fragrant that I didn't want to eat it because I would lose the smell. All the way to the airport I scratched at it with my teeth, making little dents in the skin, chewing small pieces with my front teeth, so that I could feel the texture against my tongue, the tiny pink pellets of sweet.

Today, I stand before a stack of dark green guavas, each perfectly round and hard. The one in my hand is tempting. It smells faintly of late summer afternoons and **hopscotch** under the mango tree. But this is autumn in New York, and I'm no longer a child.

The guava joins its sisters under the harsh fluorescent lights of the **exotic** fruit display. I push my cart away, toward the apples and pears of my adulthood, their nearly seedless ripeness predictable and bittersweet.

Some adjectives ending in -ed and -ing can be used to talk about feelings and emotions; for example, interesting, interested, boring, bored, confusing, confused.

The adjectives ending in -ed (past participles) describe how people feel about something.

The **interested** students listened to the story. (= The students felt interest.) The confused tourists did not know where to go. (= The tourists felt confusion.)

The adjectives ending in *-ing* describe the noun that causes the emotion or feeling.

The students heard an **interesting** story. (= The story caused interest.)

The movie had a **confusing** plot. (= The plot caused confusion.)

### Narrative Organization

A **narrative** is a story. It has an introduction that engages the reader's interest, details about the main event or action in the story, and a conclusion that describes the outcome.

### Introduction

- The hook gets the reader's attention.
- The middle sentences introduce an event (the action of the story) by providing background information about the people, the place, and the time.
- The thesis statement prepares the reader for the action that follows.

### **Body Paragraphs**

- The body paragraphs describe what happened in the story.
- They include details that bring the story to life.
- They often use time order to explain the event.

### Conclusion

- A conclusion describes the outcome of the event.
- Narrative essays often end with a comment about the event's importance in the writer's life.

### Showing Sequence in Narrative Essays

In narrative essays, we use **time expressions** to clarify the sequence of events. We use connectors **(time adverbs)** such as *then, finally*, or *eventually* to link sentences within a paragraph.

We use subordinating conjunctions to link clauses within a sentence.

### **Time Adverbs**

We use time adverbs such as *afterward*, *after that*, *eventually*, *finally*, *later*, *later on*, *now*, *then*, and *suddenly* as connectors. These connectors usually appear at the beginning of a sentence. When they do, they are immediately followed by a comma.

Then is an exception. It is not followed by a comma.

Our train was running late. Finally, it arrived.

We got on board the train. Then we realized that we did not have money for the fare.

# Using Subordinating Conjunctions with the Simple Past

Language and Grammar Focus

We use **subordinating conjunctions** such as *before, as soon as, after, when,* and *while* in complex sentences as connectors. Complex sentences contain a main (independent) clause and a dependent clause.

The main clause expresses the principal and independent idea of the sentence. The dependent clause expresses additional information about the main idea (for example, where or when it happened) but would be meaningless without the main idea.

Dependent time clauses tell us when something happened.

Subordinating conjunctions establish the time relationship between the dependent time clause and the main clause in the sentence. The subordinating conjunction starts the dependent clause, but the clauses can come in either order. We use a comma when the time clause comes before the main clause.

### time clause

After our parents left the hotel, Before my **brother** was born,

### main clause

We went into the street I was an only child

#### main clause

we went into the street. I was an only child.

### time clause

**after** our parents left the hotel. before my **brother** was born.

# Language and Grammar Focus 🖌

### Using the Past Continuous in Narrative Essays

In a narrative, you often need to describe actions in progress or to describe background actions.

To form the **past continuous**, use *was/were* and the base form of the verb + -*ing*.

Use the past continuous to talk about activities that were in progress at a specific time in the past. The activities began before the specific time and may also have continued after that time.

At three o'clock we **were walking** home from school. My friend was **riding** his bicycle.

Also use the past continuous to describe background actions.

The sun was going down, and the children were still playing on the grass.

We don't usually use stative verbs (*be, know, own, mean, seem, understand, love, believe, etc.*) in the past continuous. We use the simple past instead.

I didn't know John then.

A comparison-contrast essay can be used to illustrate the similarities and differences between one idea or image and another. Often these comparisons help us to see the image or idea in a new way.

Sometimes living and working in another place can be quite a shock. In this article, award-winning economist Mohammad Yunus describes his experience as a Ph.D student in the United States.

#### Learning about Differences

Despite my success, I still wanted to study and teach. So when I was offered a Fulbright scholarship in 1965, I jumped at the chance to get a Ph.D in the United States. This was my third trip abroad. As a Boy Scout I had gone to Niagara Falls, Canada, in 1955 and to Japan and the Philippines in 1959. But this time I was on my own, and I was in for some surprises.

At first the University of Colorado campus in Boulder was quite a shock. In Bangladesh, students never called professors by their first names. If one spoke to "sir," it was only after being invited by "sir" to speak, and then one spoke in **enormously** respectful terms. But in Boulder, teachers seemed to consider themselves friends of the students. I often saw faculty and students **sprawled out** on the lawn **barefoot**, sharing food, joking, and chatting. Such familiarity was totally unthinkable in Bangladesh. And as for the young female students in Colorado, well, I was so shy and embarrassed I did not know where to look.

At Chittagong College, female students were the minority. Of a student body of eight hundred, no more than one hundred and fifty were women. Women were also **segregated**. They were usually confined to the Women's Common Room, which was off-limits to male students. Their participation in student politics and other activities was limited. When we staged plays, for example, women were not allowed to participate.

My female students at Chittagong University were extremely shy. When it was time for class, they would **huddle** in a group just outside the Teachers' Common Room and then follow me to class, **clutching** their books and looking down at their feet so as to avoid the stares of the boys. Inside the classroom they sat apart from the boys, and I learned not to ask them questions that could possibly embarrass them in front of their classmates. I never talked to them outside the classroom.





A **comparison-contrast essay** uses **points of comparison** to show how two topics in the same category are similar and/or different.

A comparison-contrast essay can focus on similarities, differences, or both, depending on the writer's purpose.

#### Introduction

- The introduction presents the subject that is to be compared or contrasted and provides background information that helps the reader understand the writer's point of view.
- The introduction ends with a thesis statement that focuses the essay.

#### **Body Paragraphs**

- The body paragraphs have clear topic sentences that communicate whether the controlling idea will focus on similarities or differences.
- Each topic sentence is followed by supporting ideas about both topics.
- The topics being compared are addressed in the same order for clarity.

#### Conclusion

• The conclusion summarizes the differences and similarities. The writer draws a conclusion based on the information presented in the body paragraphs.

#### **A Bi-Cultural Driver**

When I first moved to Houston, Texas, I was nervous about driving. The cars were huge, and the streets were wide. I didn't want to get lost in a strange neighborhood, and I did not like going fast. Eventually, I got my American driver's license and became more comfortable with the strange city traffic. I learned to drive naturally in Houston, and life got easier. However, I was very surprised when I returned to Iran after three years. I discovered that I was afraid to drive in Esfahan, my own hometown. I had forgotten that there are major differences between driving in the United States and driving in Iran. The differences start with the way the streets are organized. In Esfahan, everything looks smaller. Many of the streets are narrow because they used to be alleys for walking. When buildings were torn down, city planners used the space to make room for cars, but there is still not very much room. Fortunately, the cars are usually smaller too, so they can fit in these smaller streets. In Houston, the streets are very wide. Sometimes they have six lanes. There are special lanes for turning left and right. Even the traffic lights are bigger because they have a lot of arrows. These arrows give drivers permission to make left turns.

The biggest difference is the way the drivers behave in each place. Esfahani drivers pay attention to other drivers but not the rules. Cars move from lane to lane so much that they look like fish trying to push their way down a river. When the traffic is not moving very fast, Esfahani drivers will go through a red light without stopping, and they do not wait for a light to make a left turn. While drivers honk at the cars turning left, they are not surprised. These drivers do the same thing when they turn, so they know what to expect.

In contrast to drivers in Esfahan, Houston drivers almost always follow the rules, but they do not pay as much attention to other drivers. Houstonians stay in their lanes or use their signals when they want to change lanes. They stop and wait for a turn signal or a green light, and they always stop at stop signs, even when there are no other drivers around. They are very surprised when other drivers do not follow the traffic rules, and they get angry if they see other drivers driving between lanes.

When I returned to Iran, I discovered that I had changed. I was more like a Houston driver. I was waiting for people to follow the signals, and I did not pay attention to other drivers. I almost got into an accident. However, after a couple of weeks, my old habits started to come back, and I was able to drive Esfahani style once again. Now I feel proud that I am a bi-cultural driver. I know the language of the road in Iran and in the United States.

A few families take a walk in the city's Central Park, but by ten o'clock the streets are pretty deserted. In Xela people eat their breakfast at home, and most come home from work for a much more relaxed and longer lunch. In contrast, New Yorkers are often in such a hurry that they don't even stop to eat. For breakfast they buy food on the street and eat it while they are walking or on the subway. At lunch they order food from work and eat at their desks.

In conclusion, these are the two cities I love. For me, both are home, both are unique, and both are filled with interesting people. These places represent the best of both worlds. New York is more hurried and rushed when I need energy, and Xela gives me a slower pace when I need to relax. Together they keep me balanced.

#### Using Comparatives in Comparison-Contrast Essays

Comparison-contrast essays often use **comparatives**. Comparatives are used with adjectives, adverbs, and nouns to show differences between two subjects (people, objects, ideas, places, or actions).

#### **Comparatives with Adjectives and Adverbs**

To form the comparative of one-syllable adjectives and adverbs, add *-er*. If the adjective or adverb ends in a single vowel and consonant, double the consonant.

To form the comparative of most two-syllable adjectives and adverbs, add *more*; however, if the adjective ends in *-le*, use *-r*. If the adjective ends in a consonant + y, change y to i and add *-er*.

#### **Comparatives with Nouns**

To form the comparative of nouns, use more.

### Wireless Technology in the Land of the Thunder Dragon

There may be no traffic lights in Thimpu, the capital of Bhutan, but there is wireless Internet. The Bhutanese tried traffic lights, but soon **got rid of** them. People did not like the **impersonal** flashing lights, so they went back to a traffic officer in white gloves. This **selectivity** is just one example of how the Bhutanese are handling a difficult transition in their society. They have begun introducing modern technology while carefully guarding their thousand-yearold way of life.

For many years, geography and politics helped to maintain Bhutan's **isolation**. This **sparsely** populated democracy is high in the Himalayan mountains between India and China. Most of it is protected forest, and many villages are not **accessible** by roads. Nearly 70 percent of the population work in agriculture. Also, only a few tourists are allowed to visit every year. These tourists can easily be spotted among the Bhutanese, who dress in traditional clothing.

Today, however, a need for increased access to medicine has set the country on track to modernize its health-care system. Faced with a shortage of hospitals, doctors, and money, leaders have skipped many of the traditional steps to building **infrastructure**. Rather than building roads and **landlines**, they have gone straight to wireless technology.

Today doctors in Bhutan's remote villages use wireless technology to send their harder cases, along with X-rays and other supporting material, to Japan, India, and other countries. Experts in those countries evaluate the cases and send back treatment suggestions. In less than half the time it would take to send a patient to a hospital by ambulance (Twenty or more hours in many instances), the village doctor is able to treat the patient. While wireless technology has brought improvements to medical care and education, it has also brought other changes. Some people worry about the cultural effects that foreign media and music will have in the Land of the Thunder Dragon, as the Bhutanese call their country. Already changes in dress and behavior are evident, changes that may not be as easy to get rid of as a traffic light.



# Rhetorical Focus 🖌

#### **Opinion Organization**

In an **opinion essay**, the writer tries to convince the reader of a point of view on a controversial issue (something that people disagree about).

#### Introduction

- The hook introduces a controversial issue.
- The hook may be an anecdote, a question, or a surprising statement or fact that makes the reader want to know more.
- The middle sentences explain why the issue is important by giving background information. This background information explains the issue with details about the history or the people involved, what they want, or how it affects them.
- The thesis statement at the end presents the writer's point of view.

#### **Body Paragraphs**

- The topic sentences support the writer's main argument in the thesis.
- The following sentences support the topic sentence with reasons, facts, and explanations to help the reader understand the writer's point of view.
- The final body paragraph often includes the opposing opinion. This is called the **counter-argument**. The writer then argues against the counter-argument. This is called **a refutation**. In the refutation, the writer points out weaknesses in the counter-argument and shows how his or her own argument is stronger.

#### Conclusion

- The conclusion restates the writer's opinion but often using different, more persuasive language.
- The conclusion may also offer a warning, a prediction, or other type of comment that reinforces the writer's viewpoint.

These exciting events have made a difference in ordinary people's lives whether they realize it or not. Space exploration has not only created history, it has also provided many practical benefits for humans here on Earth.

The importance of space programs can be seen in the technology we use every day. Satellite technology allows people to make phone calls, watch TV shows, and listen to radio programs from everywhere on Earth. Also, many of the advances in computer technology were first invented to support space exploration. For example, the National Aeronautics and Space Administration (NASA) has contributed to the creation of software that people use every day in manufacturing and design. Robotic technology is another useful example. Engineers designed robots to work on the International Space Station, but now robots are being developed to do jobs here on Earth.

# Testing in the 21st Century

Before the invention of computers and the Internet, the average classroom was similar to the world outside. People worked at desks, got information from books, and wrote with pencils. However, today the outside world is very different. People can get information anytime and anywhere. They use this information in their work and daily lives. At the same time, most schools don't allow students to use this tool when they are taking tests. This policy needs to change. Clearly, if schools want to prepare students for the future, they need to allow college students to use the Internet when they are taking tests.

Students should have Internet access while they are taking tests because the Internet is the most important tool in the modern world. Like other tools, students need to learn to use the Internet if they want to be successful. For example, an accountant who knows how to get information about tax laws will save clients' money. A doctor who can get correct information about new medicines can help her patients. In addition, information changes quickly. For example, new scientific information replaces old information every day. No human can learn about or remember all the changes, so people are better off if they can look up the newest information. Finally, people are using more information now than in the past. Take today's global economy. Business students need to learn about different markets and products, and they need to know where to get the best information. Having experience using the Internet to get the right information is more helpful than studying textbooks with information that may not be true anymore. Old-fashioned people say students need to study facts and information and then use their memories to take tests. They say being able to memorize is important. They have a point. 

#### **Counter-Argument and Refutation**

To make an opinion essay as persuasive as possible, the writer includes a **counterargument** and a **refutation**.

The counter-argument is the opposing opinion. It disagrees with the writer's position. By including the counter-argument, the writer shows an understanding of other points of view.

The refutation is the writer's response to the counter-argument. In the refutation, the writer shows why the counter-argument is weak and the writer's position is strong. The refutation may also address doubts the reader may have about the writer's position.



In the above example, the writer raises a counter-argument (that people think children are unhappy without siblings). Then the writer gives a refutation—only children are not unhappy—and then gives reasons to support the argument.

# Language and Grammar Focus 🖉

#### Using Quantity Expressions in Opinion Essays

In an opinion essay, writers often make general statements. It is important to avoid making a statement that is true for some but not for all members of a group or category. This is called an **overgeneralization**. Compare the following statements.

Cats hate water. Most cats hate water.

The first statement suggests that all cats in the world hate water. It is untrue because some cats, such as tigers, are good swimmers and enjoy being in water. In the second statement, the writer uses the **quantity expression** *most*. The quantity expression qualifies, or limits the generalization, so that the statement is true.

#### **Quantity Expressions**

The following patterns guide the use of quantity expressions:

- *Most, a lot of,* and *some* are used with both plural count nouns and noncount nouns.
   Most dormitories have Internet access.
   Some fast food can be healthy.
- *Much* and *a little* are used with noncount nouns. (*Much* is not usually used in affirmative statements. Use *a lot of* instead.)
   Some people have **a lot of** intelligence, but they do not have **much** common sense.

Students might have a little money left for entertainment after paying expenses.

*Many, several*, and *a few* are used with plural nouns.
 Many websites charge a fee for information.
 A few uncooperative participants can destroy a meeting.

#### Using Connectors to Show Support and Opposition

When we explain an opinion, we can use **connectors** to clarify the relationship between ideas. Connectors can be used to signal that the second idea will support the first in some way. They can also be used to contrast the first idea with an opposite or very different idea.

#### **Connectors That Show Support**

One way to support an idea is to give an example that illustrates the idea. Connectors like *for example* and *in particular* introduce examples.

Most people are willing to spend money to make their lives easier; for example, most new homes have wireless capabilities.

Children should avoid junk food; in particular, they should stay away from sugary snacks.

A second way to show support is to add facts or explanations that clarify the idea. The automobile industry is responding to consumer demands for more fuel-efficient cars; **in fact**, the number of available models has tripled in the past three years.

#### **Connectors That Show Opposition**

It is sometimes difficult for the writer to show that two ideas are opposed to each other. Connectors like *however* and *in contrast* help the writer focus the reader's attention on differences.

Electronic books are becoming more popular; **however**, many people still prefer to read on paper.

Standard vacations promise relaxation; in contrast, extreme tours promise danger and adventure.

When a connector is used to connect two ideas, a semicolon comes before the connector. Then the connector is followed with a comma.



# Rhetorical Focus 🔎

#### **Cause-and-Effect Organization**

A **cause-and-effect essay** explains why something happens. Both causes and effects are examined in longer essays. For now, we will focus only on causes that lead to an event or situation.

#### Introduction

- The hook engages the reader's interest. It personalizes the topic or shows why it is important for the reader to know about it.
- The middle sentences describe the event or situation that is the result of the causes. This background information helps the reader understand the relationship between the causes and the effects.
- The thesis statement at the end of the introduction states the causes that lead up to the event or situation. It may also include a comment by the writer that explains why it is important to understand the causes.

#### **Body Paragraphs**

- The body paragraphs support the thesis statement by explaining the causes in detail.
- Each body paragraph begins with a topic sentence that states one cause for the event or situation.
- The sentences that follow support the idea in the topic sentence. These supporting sentences include details such as examples, descriptions, reasons, and facts to help the reader understand the relationship between the cause and the event.

#### Conclusion

- The conclusion restates the thesis statement using different words and language.
- The conclusion summarizes the main causes and their relationship to the event.
- The conclusion may include a comment by the writer that explains why it is important to understand the causes of the event.





# Maybe Not a Professional Athlete, but Still a Success

At this moment, somewhere in the world a young boy is dreaming about becoming a famous soccer player. He has posters of famous soccer stars in his room, and every day he goes out to practice with his friends. He even cuts his hair in the same style as his favorite player. Thousands of young people feel the same as this boy. Only a few children actually become professional athletes, but all of them will learn valuable skills while they pursue their dream. The factors that determine if an individual can have a successful career in professional sports include physical ability, mental clarity, and the ability to work well with others.

To become a professional athlete, a person must stay healthy and physically strong. A soccer star should be able to run faster and farther than most other athletes. A basketball player has to be able to fake, block, and shoot while other powerful players are trying to stop him. Athletes need the support of their families. Finally, to make a career of sports, the player must be able to avoid injuries. Many young athletes have to quit because they have sports injuries from playing year after year. A tennis player might feel a lot of stress, which could interfere with her ability to concentrate. She might hit the ball out of bounds. A crowd of people yelling at a baseball pitcher might make him throw balls instead of strikes. To succeed, an athlete must be able to play under this kind of pressure. Athletes need the right kind of equipment to perform at their peak. In addition, an athlete must be able to make quick, strategic decisions. Making the right decision to pass or shoot, for example, is extremely important, especially in team sports.

Finally, an athlete must be able to cooperate with his team members. So even though he might want to keep the ball and make all the shots, he must focus on passing the ball to the player who has the best chance of scoring. He must follow and trust his coach's strategies for the team, even if it means he will not score the winning shot. He must understand his teammates' abilities and know who is the fastest player and who is the most accurate. He cannot think only about himself if he wants his team to win.

In conclusion, the three contributing factors to a successful career in athletics are physical ability, mental clarity, and the ability to work well with others. Not all children will become professional athletes, but these skills will be valuable to them later in their lives. Staying healthy will help them grow and live longer lives. Developing a strong mind will help them do well in school and in careers. And if they learn to work well with others, they will get along well with colleagues and friends.

**Phrasal verbs** are a combination of a verb + other words (often a preposition) that gives a specific meaning of an action. Sometimes following a verb with a different preposition can dramatically change its meaning.

#### **Step 1: Stimulating Ideas**

Begin writing by gathering ideas. Read your assignment carefully, and make sure you understand the task. Then think about what you already know about the topic.

Strategies: Highlight important parts of your assignment. Talk to classmates about your ideas, and write about them in your journal. Circle the ideas that are the most interesting to you. Then choose one to write about.

#### **Step 2: Brainstorming and Outlining**

Make a plan that has a clear focus and a logical sequence. To write in a way that the reader will understand, organize your ideas into an introduction, body paragraphs, and a conclusion.

Strategies: Create a list, diagram, chart, or web. Use it to decide how you will organize your essay. Think about your audience and purpose as you organize. Also make a list of vocabulary words that you think you will use. Check your assignment again to be sure your plan matches the assignment. Finally, make an outline that will guide your drafting process.

#### **Step 3: Developing Your Ideas**

Write a first draft that explains your ideas. Try to follow the outline, and explain the ideas as clearly as you can. You may change your ideas as you write to better support your thesis and to add details.

Strategies: Review your assignment before you write your first draft. Double space so that you have room to make changes later. When you finish, reread your work. Add connectors to make your ideas flow more effectively, remove anything that does not support your thesis, and add details that will make your writing clearer. Have a peer read your paper and give you feedback.

#### **Step 4: Editing Your Writing**

Your second draft and sometimes third draft give you opportunities to clarify your meaning and check grammar, vocabulary, spelling, and punctuation. The final draft should be easy to read and should have no mistakes.

Strategies: Use a checklist to look for mistakes in subject-verb agreement, verb tense, singular/plural forms, word forms, word order, and punctuation. Also check a dictionary for any vocabulary or spelling questions you have. Then write a final draft. Make sure this final draft has one-inch margins, is double spaced, has a title, and lists your name, date, and class on the top of the first page.

#### Commas

A comma (,) is used to separate information from other parts of the sentence.

- **1.** A comma is used to separate items in a series. Use *and* before the last item if listing three or more items.
  - We made rice, chicken, salad, and cake.
- 2. A comma is used to separate an introductory word or phrase.
  - At the end of the day, my husband and I sit on the sofa and talk.
- **3.** A comma is used after a dependent clause when the dependent clause precedes (or introduces) an independent clause.
  - When the power went off, we could not listen to the radio.
- **4.** A comma is used to separate two main clauses when there is a conjunction such as *and*, *but*, or *so* that shows a relationship between the clauses.
  - The temperature was below freezing, but we were warm.
- **5.** A comma is used to separate an appositive from the rest of the sentence. An appositive appearing after any noun in a sentence is set off with commas.
  - We used to visit Miraflores, a beach community near Lima.
  - The speaker, an Ecuadorian economist, supported his points with facts and statistics.

#### Periods

Periods (.) are used to mark the end of a sentence.

She speaks four languages.

#### Colons

Colons (:) are used to introduce a list of items. They can be particularly helpful when writing thesis statements because they allow the writer to introduce the major ideas.

Colons must be preceded by an independent clause. They can be followed by a group of words, phrases or, in some cases, clauses.

 To build a tree house, you will need the following items: nails, a hammer, boards, and a tape measure.

#### Semicolons

Semicolons (;) are used at the end of sentences. They follow the same rules as periods; however, they are only appropriate if the relationship between the two sentences is close.

- **1.** Semicolons are used between two separate sentences.
  - They help each other; Emily does the bookkeeping while Amina takes care of customers.
- **2.** Semicolons are used when two sentences are joined by a connector such as *however* or *therefore*.
  - The Earth's oceans still hold many secrets; however, new technology is helping scientists to understand them better.

#### Apostrophes

Apostrophes (') are used to show possession.

- **1.** When a noun is singular, add an apostrophe and *s* to show possession. In the first example, the writer has one cousin.
  - We went to my cousin's house.
- **2.** When a noun is plural, put the apostrophe after the plural *s*. In the next example, the writer has more than one cousin.
  - We went to my cousins' house.
- **3.** When a noun ends in *s*, you may add the apostrophe + *s* after the final *s* or just the apostrophe.
  - My boss's car was ridiculously expensive.
  - My boss' car was ridiculously expensive.

Apostrophes are also used in contractions. (Note, however, that contractions are not appropriate in most academic writing.)

Scott doesn't have any hair.

#### **Quotation Marks**

Quotation marks ("...") are used to show that you are repeating or quoting someone else's words.

Put quotation marks around only the exact words you take from someone else's speech or writing. Use a comma to separate the quote from the rest of the sentence.

· I heard him say, "Don't worry about the report, Mr. Noor. I will take care of it."

#### Appendix IV Glossary

#### Adapted from the Grammar Sense Glossary of Grammar Terms

**action verb** A verb that describes a thing that someone or something does. An action verb does not describe a state or condition.

Sam rang the bell.

It rains a lot here.

**active sentence** In active sentences, the agent (the noun that is performing the action) is in subject position, and the receiver (the noun that receives or is a result of the action) is in object position. In the following sentence, the subject *Alex* performed the action, and the object *letter* received the action.

Alex mailed the letter.

**adjective** A word that describes or modifies the meaning of a noun.

the orange car a strange noise

**adverb** A word that describes or modifies the meaning of a verb, another adverb, an adjective, or a sentence. Many adverbs answer such questions as *How? When? Where?* or *How often?* They often end in *-ly.* 

She ran quickly.She ran very quickly.a really hot dayMaybe she'll leave.

**adverbial phrase** A phrase that functions as an adverb.

Claudia spoke very softly.

**affirmative statement** A sentence that does not have a negative verb.

Linda went to the movies.

**agreement** The subject and verb of a clause must agree in number. If the subject is singular, the verb form is also singular. If the subject is plural, the verb form is also plural.

He comes home early. They come home early.

**article** The words *a*, *an*, and *the* in English. Articles are used to introduce and identify nouns.

a potato an onion the supermarket

**auxiliary verb** A verb that is used before main verbs (or other auxiliary verbs) in a sentence. Auxiliary verbs are usually used in questions and negative sentences. *Do, have,* and *be* can act as auxiliary verbs. Modals (*may, can, will*...) are also auxiliary verbs.

Do you have the time? The car was speeding.

I have never been to Italy. I may be late.

**base form** The form of a verb without any verb endings; the infinitive form without *to*.

sleep be stop

**clause** A group of words that has a subject and a verb. *See also* **dependent clause** and **main clause**.

If I leave,	when he speaks.
The rain stopped.	that I saw.

**common noun** A noun that refers to any of a class of people, animals, places, things, or ideas. Common nouns are not capitalized.

man cat city pencil grammar

**comparative** A form of an adjective, adverb, or noun that is used to express differences between two items or situations.

This book is heavier than that one.

He runs more quickly than his brother.

The DVD costs more money than the CD.

**complex sentence** A sentence that has a main clause and one or more dependent clauses.

When the bell rang, we were finishing dinner.

**compound sentence** A sentence that has two main clauses separated by a comma and a conjunction, or by a semi-colon.

She is very talented; she can sing and dance.

**conditional sentence** A sentence that expresses a real or unreal situation in the *if* clause, and the (real or unreal) expected result in the main clause.

If I have time, I will travel to Africa.

If I had time, I would travel to Africa.

**count noun** A common noun that can be counted. It usually has both a singular and a plural form.

orange — oranges woman — women

**definite article** The word *the* in English. It is used to identify nouns based on assumptions about what information the speaker and listener share about the noun. The definite article is also used for making general statements about a whole class or group of nouns.

Please give me the key.

The scorpion is dangerous.

**dependent clause** A clause that cannot stand alone as a sentence because it depends on the main clause to complete the meaning of the sentence. Also called *subordinate clause*.

I'm going home after he calls.

**determiner** A word such as *a*, *an*, *the*, *this*, *that*, *these*, *those*, *my*, *some*, *a few*, and all numbers used before a noun to limit its meaning in some way.

those videos

**future** A time that is to come. The future is expressed in English with *will*, *be going to*, the simple present, or the present continuous. These different forms of the future often have different meanings and uses.

I will help you later.

David is going to call later.

The train **leaves** at 6:05 this evening.

I'm driving to Toronto tomorrow.

**gerund** An *-ing* form of a verb that is used in place of a noun or pronoun to name an activity or a state.

Skiing is fun. He doesn't like being sick.

**if clause** A dependent clause that begins with *if* and expresses a real or unreal situation.

If I have the time, I'll paint the kitchen.

If I had the time, I'd paint the kitchen.

**indefinite article** The words *a* and *an* in English. Indefinite articles introduce a noun as a member of a class of nouns or make generalizations about a whole class or group of nouns.

An ocean is a large body of water.

independent clause See main clause.

**indirect object** A noun or pronoun used after some verbs that refers to the person who receives the direct object of a sentence.

Hassan wrote a letter to Samuel.

Please buy some milk for us.

**infinitive** A verb form that includes *to* + the base form of a verb. An infinitive is used in place of a noun or pronoun to name an activity or situation expressed by a verb.

Do you like to swim?

**intransitive verb** A verb that cannot be followed by an object.

We finally arrived.

**main clause** A clause that can be used by itself as a sentence. Also called *independent clause*.

I'm going home.

**main verb** A verb that can be used alone in a sentence. A main verb can also occur with an auxiliary verb.

I ate lunch at 11:30.

Kate can't eat lunch today.

**modal** The auxiliary verbs *can, could, may, might, must, should, will,* and *would.* They modify the meaning

of a main verb by expressing ability, authority, formality, politeness, or various degrees of certainty. Also called *modal auxiliary*.

You should take something for your headache.

Applicants must have a high school diploma.

**negative statement** A sentence with a negative verb. | **didn't see** that movie.

**noun** A word that typically refers to a person, animal, place, thing, or idea.

**noun clause** A dependent clause that can occur in the same place as a noun, pronoun, or noun phrase in a sentence. Noun clauses begin with *wh*– words, *if, whether,* or *that.* 

I don't know where he is.

I wonder if he's coming.

I don't know whether it's true.

I think that it's a lie.

**noun phrase** A phrase formed by a noun and its modifiers. A noun phrase can substitute for a noun in a sentence.

She drank milk. She drank chocolate milk.

She drank the milk.

**object** A noun, pronoun, or noun phrase that follows a transitive verb or a preposition.

He likes <b>pizza.</b>	Go with her.
She likes tennis.	Steve threw the ball.

**passive sentence** Passive sentences emphasize the receiver of an action by changing the usual order of the subject and object in a sentence. In the sentence below, the subject (*The letter*) does not perform the action; it receives the action or is the result of an action. The passive is formed with a form of *be* + the past participle of a transitive verb.

The letter was mailed yesterday.

**past continuous** A verb form that expresses an action or situation in progress at a specific time in the past. The past continuous is formed with *was* or *were* + verb + -ing. Also called *past progressive*.

A: What were you doing last night at eight o'clock?

B: I was studying.

**past participle** A past verb form that may differ from the simple past form of some irregular verbs. It is used to form the present perfect.

I have never seen that movie.

**phrasal verb** A two- or three-word verb such as *turn down* or *run out of*. The meaning of a phrasal verb is usually different from the meanings of its individual words.

She turned down the job offer.

Don't run out of gas on the freeway.

**phrase** A group of words that can form a grammatical unit. A phrase can take the form of a noun phrase, verb phrase, adjective phrase, adverbial phrase, or prepositional phrase. This means it can act as a noun, verb, adjective, adverb, or preposition.

The tall man left. She spoke too fast. Lee hit the ball. They ran down the stairs.

**preposition** A word such as *at, in, on,* or *to* that links nouns, pronouns, and gerunds to other words.

**prepositional phrase** A phrase that consists of a preposition followed by a noun or noun phrase.

on Tuesday under the table

**present continuous** A verb form that indicates that an activity is in progress, temporary, or changing. It is formed with be + verb + -ing. Also called *present progressive*.

I'm watering the garden.

Ruth is working for her uncle.

**present perfect** A verb form that expresses a connection between the past and the present. It indicates indefinite past time, recent past time, or continuing past time. The present perfect is formed with *have* + the past participle of the main verb.

I've seen that movie.

The manager has just resigned.

We've been here for three hours.

**pronoun** A word that can replace a noun or noun phrase. *I, you, he, she, it, mine,* and *yours* are some examples of pronouns.

**quantity expression** A word or words that occur before a noun to express a quantity or amount of that noun.

**simple past** A verb form that expresses actions and situations that were completed at a definite time in the past.

Kwon ate lunch. She was hungry.

**simple present** A verb form that expresses general statements, especially about habitual or repeated activities and permanent situations.

Every morning I **catch** the 8:00 bus. The Earth **is** round. **stative verb** A type of verb that is not usually used in the continuous form because it expresses a condition or state that is not changing. *Know, love, see,* and *smell* are some examples.

**subject** A noun, pronoun, or noun phrase that precedes the verb phrase in a sentence. The subject is closely related to the verb as the doer or experiencer of the action or state, or closely related to the noun that is being described in a sentence with *be*.

Riko kicked the ball. The park is huge.

subordinate clause See dependent clause.

**superlative** A form of an adjective, adverb, or noun that is used to rank an item or situation first or last in a group of three or more.

This perfume has the strongest scent.

He speaks the fastest of all.

That machine makes the most noise of the three.

**tense** The form of a verb that shows past, present, and future time.

He lives in Ankara now.

He lived in Istanbul two years ago.

He'll live in Malatya next year.

**time clause** A dependent clause that begins with a word such as *while, when, before,* or *after.* It expresses the relationship in time between two different events in the same sentence.

Before Sandy left, she fixed the copy machine.

**time expression** A phrase that functions as an adverb of time.

She graduated three years ago.

I'll see them the day after tomorrow.

**transitive verb** A verb that is followed by an object. | **read** the book.

**uncountable (noncount) noun** A common noun that cannot be counted. A noncount noun has no plural form and cannot occur with *a*, *an*, or a number.

information mathematics weather

verb A word that refers to an action or a state.

Thana **closed** the window. Tsutomu **loves** classical music.

**verb phrase** A phrase that has a main verb and any objects, adverbs, or dependent clauses that complete the meaning of the verb in the sentence.

Who called you? He walked slowly.
